STANDARD MASONRY CHIMNEY AND FIREPLACE GUIDE

FOR ONE-TO-TWO FAMILY DWELLINGS

SUBMITTAL REQUIREMENTS

A permit is required for any repair, alteration and/or construction of a masonry chimney or fireplace. Permit shall be obtained prior to the start of the work.

One electronic set of plans, digitally signed by the designer/architect, contractor, or homeowner responsible for preparing the plans. All plans submitted (at minimum, include existing and new floor plans) shall be a minimum plan size of 11" x 17" and must be legible to facilitate digital imaging as a permanent record after the project is completed.

Exterior modifications to buildings require Planning review and approval prior to submittal to the Building Division.

If the property is overseen by a Homeowners Association a letter of authorization signed by the HOA, is required.

The following is a listing of the general code requirements based on the **2022** California Codes & Mountain View Municipal Code. This handout is intended to provide general information. BASIC CODE REQUIREMENTS

- 1. Provide minimum existing and proposed elevations plans, and/or sections plans.
- 2. For fireplace installation requirements visit the Mountain View City Code, Chapter 8, Sections 8.20.35, 8.20.46 & 8.25.1 8.25.5.
- 3. If fireplace removed, verify that the fireplace was not part of the stability of the existing building. Additionally, provide the proposed framing where fireplace was located (e.g. proposed foundation, floor joists, type of walls, roof rafters/ceiling joists and the required insulation) in compliance with the CRC section 4, 5, 6 & 8 and CEnerC Table 150.1-B.
- 4. Show compliance on the plans with Chapter 10, Table R1001.1 "Summary of requirements for masonry fireplaces and chimneys"; and compliance, if required, with the figure R1001.1 "Fireplace and chimney details", of the current California Residential Code:

Effective flue area (based on area of fireplace opening)	P	See Section R1003.15.
Clearances Combustible material Mantel and trim Above roof	R	See Sections R1001.11 and R1003.18. See Section R1001.11, Exception 4. 3' at roofline and 2' at 10'.


