I agree to indemnify, defend, and hold harmless City, its officers, officials, employees, and volunteers from any and all liabilities for claims, loss, demands, injury, damages, or actions by third parties that arise out of or related to my participation in the on my own behalf. In the event of a loss, I shall look solely to my own insurance coverage for recovery. My insurance coverage is primary and noncontributory. I agree to a waiver of any right to subrogation which any insurer I may acquire against City by virtue of the payment of any loss under such insurance.

I understand these photographs are intended for the noncommercial use of City and that I am to receive no compensation for the use thereof. I agree to hold the City of Mountain View harmless from any liability arising from the use of these photographs.
