## FY 2021-22 Budget Overview

- Budget development was a 7 month process
- Public Hearing for Recommended Budget on June 8—No changes made
- Budget is balanced
- Current service levels maintained despite pandemic
- Economic impacts of COVID-19 have been significant but are slowly showing signs of improvement
