## CDBG & City General Fund Funding Available for Fiscal Year 2023-2024

### NOTICE OF FUNDING AVAILABILITY FOR PUBLIC SERVICE PROGRAMS AND CAPITAL PROJECTS

The City's Fiscal Year 2020-25 Consolidated Plan outlines six priority goals and how federal grants such as Community Development Block Grant (CDBG) will be used to achieve these goals. Annual Action plans are developed each year to implement the Five-Year Consolidated Plan and include a summary of the activities and projects that will be funded to further the priority goals. These goals are:

- Increase affordable housing for lower-income and special-needs households
- Establish and support programs to prevent and end homelessness
- Support activities that promote safety, security, wellness, and well-being for lower-income households and special-needs populations, such as seniors, abused and neglected youth, and the disabled
- Support programs and activities that strengthen and enhance neighborhoods
- Promote fair housing opportunities; and
- Promote economic resiliency and improve workforce development and skills training.

Additionally, an allocation from the City's General Fund each year is used to supplement CDBG funds (see table below for eligible activities).

The City of Mountain View is currently accepting applications for Fiscal Year 2023-24 (July 1, 2023 - June 30, 2024):

- CDBG & City of Mountain View General Funds for Public Service programs that serve lower income households
- CDBG fund for Capital Projects for eligible project activities and to implement a minor home repair program

Funding will be awarded subject to recommendations from the Human Relations Commission and approval by the City Council in late April 2023 and the Program year starts on July 1, 2023.
