Any party of interest may, prior to the date designated hereinabove, file a claim with the City's Finance and Administrative Department which includes the claimant's name, address, telephone number, Social Security Number or Federal Employer Identification Number, amount of claim, and the grounds on which the claim is founded. Proof of identity acceptable to the City, such as a copy of a driver's license, Social Security card, or birth certificate, must be provided before funds will be released. For business, proof should include a letter of authorization on company letterhead, valid business license, or other document verifying identity.

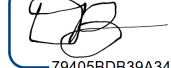
